

# MINUTES FROM KOCHS SCHOOL ANNUAL MEETING

## 1. Election of rapporteur

The school recommended the school's office manager, Tonja Althaus, as rapporteur. Tonja was elected.

#### 2. Election of Chairman

Morten Rüdevald (former parent) was elected. Morten stated that the annual meeting was lawfully announced and quorate in accordance with the articles of association.

Questions or comments on both reports:

How will the relocation of the Kochs International department affect the school's students? Jens explained that the KI students will physically be closer to the RED and YELLOW floors in the upcoming redevelopment, where there will be a more natural traffic / flow for everyone. A joint FO/Club meeting place has been needed.

#### 5. Presentation of audited accounts

Presented by auditor, Morten Gade Steinmetz, Deloitte

The Parent's Board and the School's Management are responsible for the accounts. The auditor has a duty to review the entire school's finances, and subsequently prepares an audit



report as well as an audit report for the accounts - and these endorsements are blank and without remarks.

Morten subsequently reviewed the key figures for the years 2017 to 2021, including, amongst other things, the increasing turnover which is an expression of the growing number of students at the school and the result for the year which is DKK 3.9 million, which is very impressive. The income statement and balance sheet were generally reviewed and showed that the school's finances are in good shape in relation to planned future construction.

#### 6. Election of parent representatives to the board
